Public/Legal Notification	The Planning Staff is responsible for placing the Public/Legal Notification for the Board of Zoning Appeals public hearings and will be published in the Hendricks County Republican at least twelve (12) days prior to the date of the Board of Zoning Appeals meeting.			
Written Notification & Sign Posting	The Petitioner is responsible for the Written Notification & Sign Posting. Written Notification to surrounding property owners for Board of Zoning Appeals public hearings may be sent by first class mail and postmarked at least ten (10) days prior to the date of the Board of Zoning Appeals meeting. Posting signs for each case being heard must also be completed at least ten (10) days prior to the meeting. **The signed and notarized affidavits will serve as proof of the Written Notification & Sign Postings and must be filed with the Planning Staff prior to the Board of Zoning Appeals meeting to avoid continuance. **
